#### To be eligible to apply you must:

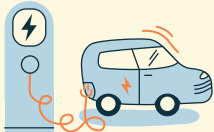
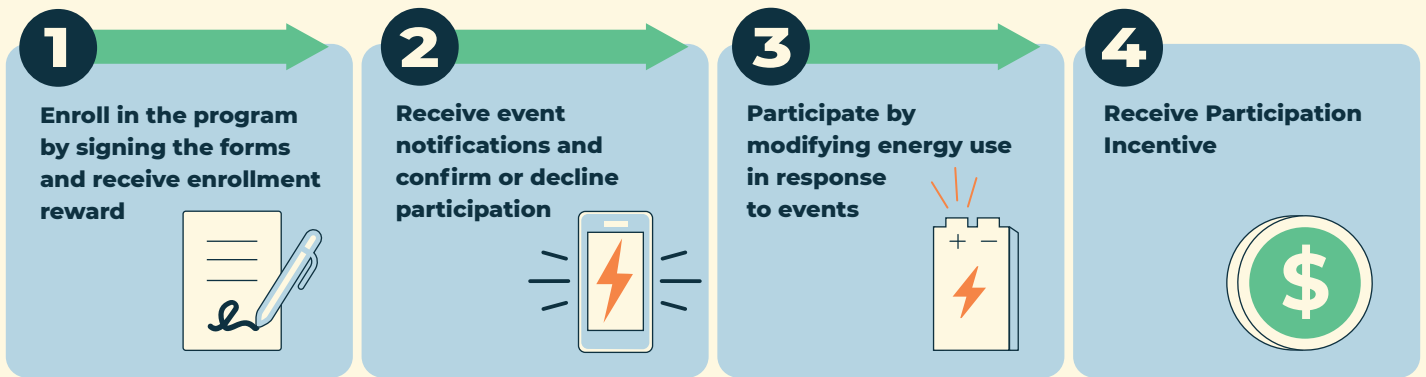
- Be a Clean Power Alliance commercial, industrial, or municipal customer
- Have a battery energy storage system or electric vehicle chargers connected to the internet and the grid
- Agree to modify your equipment usage in response to up to 5 energy savings events per month

**Earn a \$250 enrollment reward and a yearly \$100/KW participation reward.**

Higher incentives available for customers located in targeted low-income areas.

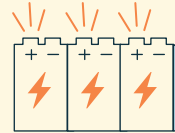
Customers enrolled in SCE's Capacity Bidding Program or Base Interruptible Program, or other similar Demand Response programs, are not currently eligible to enroll unless they disenroll from those programs.

## How does the CPA Power Response program work?



### Electric Vehicle Chargers

- Available to Clean Power Alliance customers with Level 2 electric vehicle chargers from qualified vendors/technology suppliers.
- Minimum 5 kW capacity commitment and a minimum of 3 charging units used daily per facility.
- Clean Power Alliance provides personalized consultation to help identify the appropriate amount of capacity to commit.
- Olivine, Inc. will connect to your EV charging technology/management provider and send instructions to modulate your charging.



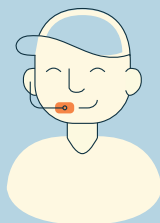
### Battery Energy Storage

- Available to Clean Power Alliance customers with existing battery energy storage systems from qualified vendors / battery management system suppliers.
- Minimum 10 kW capacity commitment per facility.
- Clean Power Alliance provides personalized consultation to help you identify the appropriate amount of capacity to commit.
- Olivine, Inc. will connect to your battery management provider and send instructions to discharge your battery.
- For customers without an existing battery, Clean Power Alliance provides personalized consultation for battery sizes and cost estimates.
- Solar-paired or standalone storage
